TUG RELEASE POINTS UPDATE

Earlier this year the Tug Release Points (TRPs) went live on a trial basis along with a logical renumbering of taxiway parking positions, which now reflect the holding points at which they are located.

Despite one or two teething issues the process has been successful. LBA would like to thank all ground & aircrews as well as ATC for their support so far throughout this transition.

The ATC trial period has now ended.

The TRPs are live & will be included on the new LBA AIP plates when released.



AOI 05/2018 refers to this operational change. Make sure staff have access to it.

APRON 101 -DOUBLE WHITE LINES

The painted double white lines represent the boundary between the apron and the live aircraft taxiway.

STAFF MUST NOT CROSS THE DOUBLE WHITE LINES EXCEPT:

- With express permission from Leeds ATC
- Proceeding to an aircraft parked on a taxiway parking position and apron ops are in force (eg. AP1, AP2, NP4, NP3)
- Carrying out an aircraft pushback.

DRIVING WHILST USING HANDHELD DEVICES

It's pretty simple.

Anybody caught driving whilst looking down at phones or radios will have their airside driving permit **REMOVED**.

CCTV is also being monitored

APRON SPEED NEW SPEED DETECTION WARNING SIGNS

As part of our commitment to reduce the number of airside incidents involving vehicles. LBA has implemented 3 Radar tracking SDWS at various points along the apron road.

The SDWS are solar powered with large battery storage capacity and will be operational H24. The devices

give LBA the ability to collect traffic data of approaching vehicles, showing vehicle speed classes,

Average speed, highest speed and percentile speed counts.







- 13 MPH Speed is indicated in the top circle.
- 15 MPH activates the "SLOW DOWN" command.



*** Multiple CCTV cameras are focused on the signs and apron road which further assist in identifying any airside driver breaching the respective speed limits.

Airside Operations will be issuing non-compliances and an automatic three points to any driver observed exceeding the speed limit.



Non-Compliance Review (2nd March – 27th August 2018)

Reason	Non-compliances issued
Vehicle infringing on stand causing halt to push back	1
Driving through yellow hatched area at fuel farm	1
Failing to stop at illuminated fire station warning lights	1
Driving behind live aircraft	4
Vehicle vs vehicle collision	1
Driving in front of / behind marshaller	2
Reversing into oncoming traffic (reversing without marshaller)	1
Vehicle vs equipment/infrastructure collision	7
Driving in front of APIS stand 7	1
Hard braking in a passenger carrying vehicle	1 (1 NFA)

Total of 20 non-compliances issued

Average of 0.77 non-compliances issued per week
